## TITLE: Appointment of Northland Civil Defence Emergency Management Group Chairperson

## Purpose

The purpose of this report is to set out the process for the appointment of the CDEM Group chair and deputy chairperson appointments.

## Report

The meeting Secretary will call for nominations for election to the office of Chairperson and deputy chair pursuant to Clause 25(2) and (3) of Schedule 7 to the Local Government Act 2002.

A proposer and seconder will be required for each nomination. Any nomination that is proposed but not seconded, will be deemed to have lapsed.

If only one nomination is received, that person will be declared to be elected.

Should more than one nomination be received, the Committee will be called upon to decide which of two systems of voting is to be used to make the appointment.

These voting systems are specified in Clause 25 of Schedule 7 to the Local Government Act, are as follows:

#### System A—

(a) requires that a person is elected or appointed if he or she receives the votes of a majority of the members of the local authority or committee present and voting; and

(b) has the following characteristics:

(i) there is a first round of voting for all candidates; and

(ii) if no candidate is successful in that round there is a second round of voting from which the candidate with the fewest votes in the first round is excluded; and

(iii) if no candidate is successful in the second round there is a third, and if necessary subsequent, round of voting from which, each time, the candidate with the fewest votes in the previous round is excluded; and

(iv) in any round of voting, if 2 or more candidates tie for the lowest number of votes, the person excluded from the next round is resolved by lot.

#### System B—

(a) requires that a person is elected or appointed if he or she receives more votes than any other candidate; and

(b) has the following characteristics:

- (i) there is only 1 round of voting; and
- (ii) if 2 or more candidates tie for the most votes, the tie is resolved by lot.

## TITLE: Tsunami Warning - Kaikoura Earthquake

#### Introduction

The purpose of this report is to provide an overview of the initial response to the Kaikoura earthquake by the Northland Civil Defence Emergency Management Group. The sequence of events outlined below is a timeline for the critical notifications and actions in Northland.

#### Timeline of events

At 12.02 am on Monday 14 November 2016 an earthquake occurred northeast of Culverdon, in the South Island. Strong to severe shaking was felt throughout New Zealand and lasted for over two minutes in some locations.

At 12.17 am the Pacific Tsunami Warning Centre (PTWC) issued an information statement advising an earthquake of a preliminary magnitude 7.4 had occurred in the South Island at 1103 (UTC) (1203 am NZST). The PTWC advised that based on all the available data that No Tsunami threat was evident.

At 12.24 am the Ministry of Civil Defence & Emergency Management issued a text and email via the National Warning System (NWS) - National Earthquake Advisory magnitude 6.6 earthquake 20 km south-east of Hamner Springs. This notification advised of the earthquake event. No mention was made of a tsunami. (Inland earthquakes generally do not generate tsunami).

At 12.40 am MCDEM via the NWS issued a Tsunami Advisory stating that the Pacific Tsunami Warning Centre (PTWC) had issued a Tsunami Information Statement in response to the magnitude 6.6 earthquake. The message advised that "Only messages issued by MCDEM represent the official warning status for New Zealand. MCDEM had assessed the information with the assistance of scientific advisors. Based on current information, the initial assessment is that the earthquake is unlikely to have caused a tsunami that will pose a threat to New Zealand."

At 12.48 am the No threat information was posted to the Northland Facebook page by the Duty Officer, which is standard operating procedure when events of this scale and magnitude occur.

At 12.54 am the PTWC issued a second information statement advising that an earthquake with a preliminary magnitude 7.9 had occurred in the South Island and that a drawdown of 2.5 meters was observed at the Kaikoura tide station.

At 1.00 am (date stamped 0050 hrs) MCDEM via the NWS issued a National Warning: Tsunami Threat No 1, for all southern coastal areas of New Zealand advising that a tsunami is possible. (Parameters of the earthquake were still at magnitude 6.6 and south east of Hamner Springs). The information was forwarded to the pre-determined distribution text and email lists at 1.17 am and 1.20 am respectively.

At 1.29 am (time stamped 0125 hrs) MCDEM via the NWS issued National Warning: Tsunami Threat No 2 – "Imminent Threat for Eastern coast of North and South Island including the Chatham Islands. It may arrive in the Eastern Coast of the North Island shortly. Move inland or to higher ground immediately."

Procedures were commenced to activate the Northland Tsunami Siren network and advise key staff, stakeholders and to ensure that public messaging was in place to advise of actions to be taken. (i.e. Evacuations)

At 1.36 am call to WDC Officer to commence activation of Northland wide tsunami siren network.

At 1.39 am Update # 2 was posted to Civil Defence Northland Facebook page. "The Ministry have now included the eastern coast of the North and South Island in their tsunami warning. Move inland or to higher ground immediately." This Facebook post received 15,406

At 1.46 am Top Energy and Northpower both activated the Northland tsunami siren network. (See attached map for locations of sirens). Seventeen minutes elapsed from receipt of MCDEM NWS message Tsunami Imminent notification to activation of the Northland tsunami siren network.

Regular updates were made to the Northland Civil Defence Facebook page. This Facebook post at 1.53 am received 57,762 views.

At 1.53 am MCDEM advised that a National Controllers Teleconference would be held at 2.30 am.

Police and Fire Service were activated. Both agencies responded to commence evacuations. NZ Refinery also commenced evacuation procedures.

At 2.01 am (time stamped 0200 hrs) MCDEM issued a Tsunami Threat National Warning: Tsunami Threat #3 Hamner Springs Earthquake and Tsunami Marine and Land Threat . The warning issued covered all of the eastern coast of the North Island and all of the east coast of the South Island including Chatham Islands. It contained confirmation that a tsunami was

generated with activity being detected in the areas around Kaikoura and waves were detected on the Geonet Tsunami Gauges.

At 2.20 am (time stamped 0215 hrs) MCDEM issued a National Warning: Tsunami #4 – Threat to Marine and Land Areas warning of a land threat from the East Cape to Southland including Wellington and the Chatham Islands. There is a beach and marine threat for the remainder of New Zealand."

Effectively Northlands coastline was removed from the threat area.

All Northland personnel responding to the tsunami warning information were advised of the change in warning information.

NZ Refinery, Police and Fire Service were all immediately advised in the change of warning information for the region, the Northland Tsunami Siren Network was turned off, the change in threat information immediately posted to Facebook and via the Hazard app. The Facebook page was continually updated through-out the day with the relevant information for the Northland region until the final cancellation notice as issued.

#### Hazard app

The Hazard app was used in Northland for the first time operational. There had been criticism about the lack of use during the 2 September event. The first message was sent at 1.55 am: "Sirens activated, move inland or to higher ground". The second message at 2.55 am: "Marine and beach threat only for Northland, sirens switched off." "Third message at 6.25 am: marine and beach threat lifted for Northland region."

#### Facebook

The Northland Civil Defence Facebook page was used to provide nine updates between 12.45 am and 3.08 pm. It was successfully managed by four individuals in the Civil Defence team in that time. For **each post**, the number of people reached ranged between 4000 and 57,700 people. A total of 618 people posted comments on the page, some of which were highly appreciate of our updates (with issues about hearing tsunami sirens being the other main topic). A number of other contacts via phone and email to mailroom (again some tsunami related but also one overseas parent looking for a tourist who was out of contact).

#### Summary

The response to this event was coordinated initially by personnel who were located remotely; either at home or from a hotel in Hamilton where two staff were attending the residential phase of the Controllers Course. Once sufficient staff had been engaged and timeframes permitted the Group ECC was activated at the Regional Council.

Exercise Tangaroa and the 2 September tsunami warning both highlighted areas for improvement or change in the manner in which the Northland CDEM Group and other agencies respond to a near source tsunami. Learnings from both were taken forward into this response, particularly around the early notifications of the threat, early decision making on activation of the tsunami siren network, and ensuring that all avenues were used for distribution of information i.e. Hazard app, Facebook.

Feedback has been received about the efficacy of the tsunami siren network, particularly on coverage (where a number of comments have been received about the inability to clearly hear

Page 4 of 4 the siren) and from a number who were or are still unfamiliar with the tone of the siren (comments about the siren being like a car or house alarm).

The Coordinating Executive Group is reviewing the matters raised, particularly tsunami siren coverage in the coastal areas.

Consideration is also being given to the matters associated with the tsunami warnings and response including Community Response Plans, Public Education Messages, Public Signage and the manner in which tsunami inundation maps are made available to communities.

The CEG is reviewing the available funding to support the further installation of tsunami sirens across the region. Whangarei and Far North District councils have some funding available and the CEG is considering group funding. An update on the outcome will be provided at the next group meeting.

## Kaikoura Earthquake and tsunami warning for NZ

Details of the Northland response to this event are contained in a separate agenda item.

During the national and regional response various requests were made for support staff. A total of 4 Northland CDEM personnel were provided, Kim Abbott filled the role of Welfare Manager at the Canterbury Group EOC for 5 days, Victoria Randall as the Operations Manager for the Red Cross in Christchurch for 5 days, Susan Botting in a Public Information and Media role at the NCMC for 4 days and Shona Morgan in a Welfare role at the NCMC for 4 days.

The ongoing response also required constant, daily involvement in teleconferences for the Group Controller.

Given the nature of the earthquake and the GNS forecast, or scenario predications of how the ongoing earthquake sequence might unfold it was imperative that sufficient staff were available in the region to respond if necessary.

#### Japan Tsunami

On 22 November at 10.03 am a magnitude 7.6 earthquake occurred near the east coast of Honshu in Japan. A small near source tsunami was generated by the earthquake. MCDEM via the National Warning System advised in a Tsunami Advisory at 10.28 am that there was no threat to New Zealand.

## **Resilience Fund**

At the last CDEM Group meeting it was advised that changes had been made at a national level in the manner in which the National CDEM Resilience Fund is to be administered and distributed.

The purpose of the CDEM Resilience Fund is to enhance New Zealand's disaster risk resilience through the development of local, regional, and national capability and practices. The Fund is allocated by the Director of Civil Defence Emergency Management (the Director) with guidance and advice from the CDEM Resilience Fund Review Panel, comprising CDEM Group and sector representatives.

Applications for the 2016/17 year closed in late October. There were 27 applications with a total value of \$2,230,110 for a fund of \$889,000. On 21 October MCDEM asked CDEM Groups to provide to them by 2 November feedback on the individual applications. Feedback was provided by Northland with the general observation that "Northland has over a long period of time held the view that funding should be provided to those projects that are a priority at the territorial local authority and Group level and not to larger national level projects that rightfully should be funded by MCDEM in their work programme. Northland would like to see a return to providing funding to Groups who have identified weaknesses, as an example, several applications in this round relate to the Lifelines sector (probably highlighted in Monitoring and Evaluation Reports), rather than large projects that are perceived to have national level benefits."

The panel considered the applications on 7 November, to date no formal announcement has been made on the outcomes.

#### Youth Development and Youth and Emergency Services (YES)

Earlier in the year the Minister for Civil Defence announced new funding to achieve the following objectives nationally;

• Improving participant's capability and resilience through the completion of a youth development opportunity;

• Improving participants personal, social and decision-making skills through completion of a youth development opportunity; and

• Delivering youth development opportunities targeted at young people from disadvantaged backgrounds.

As part of this project the Northland Youth Trust will be working with young offenders who are currently mentored by the NZ Police. These young people will be engage in training and mentoring from experts in civil defence, and will then take key points into consideration to create 2 short video clips about civil defence emergency procedures.

With support from film industry professionals and mentors, youth will be guided in the video making process. \$5000 has been awarded from the national fund for this project.

## TITLE: Exercise Tangaroa Evaluation Report and Outcomes

#### Introduction

The purpose of this report is to provide an overview of Exercise Tangaroa including the evaluation process, lessons learned and outcomes to be incorporated into the Northland CDEM Workplan.

#### The Exercise

Exercise Tangaroa 2016 was based on a regional source tsunami that impacted the entire New Zealand coastline. The aim of the exercise was to test New Zealand's arrangements for preparing for, responding to and recovering from a national tsunami impact. The exercise was led by the Ministry of Civil Defence & Emergency Management (MCDEM) and supported by all 16 CDEM groups, central government agencies, emergency services, lifeline utilities and other agencies and organisations as appropriate.

While national objectives were provided, Northland CDEM developed objectives specific to the region (presented in the September Exercise Tangaroa agenda item). A large amount of work was completed during the preparation phase of the exercise. An outline of this work is attached at the end of this report.

The exercise was conducted over three days, each two weeks apart. Below is a table outlining the dates, timings and locations of the exercise in Northland.

Day 1 – The focus of Day 1 (31 August) for Northland CDEM Group was around public alerting, testing the warning plan and tsunami plans, using KOBO software for rapid impact assessments, setting up the Group Emergency Coordinating Centre, and setting up/using an EMIS event site. EOC's were set up at each of the district councils and were operating at various activation levels. The Northland GECC was fully activated.

Day 2 – A welfare workshop was held on Day 2 (14 September) at NRC. This included all Group and Local welfare managers and members of the Welfare Coordination Group (WCG). The topics for the day included rapid impact assessment, incident action plans, needs assessment, status reports and attending the national welfare teleconference.

Day 3 – A recovery workshop was held on Day 3 (28 September) in conjunction with Whangarei District Council (WDC). This involved a handover from the WDC local controller to the local recovery manager, action planning, a discussion around setting up a recovery office and recovery structure suitable for Northland. Short, medium and long term goals for recovering from a large scale event were considered.

## Debrief process

At the group level, a hot debrief was held in the GECC where all participants were asked to provide feedback on the challenges and successes of Day 1. Overall they day was seen as a worthwhile experience and a good opportunity to increase awareness and relationships across council. A cold debrief was held on 14 October involving all CDEM staff and some external agencies such as emergency services and lifelines representatives. The information gathered from both debrief processes has been collected and forms the basis of the outcomes in this report.

At the local level, debriefs at the conclusion of Day 1 were held at each of the EOC's. An opportunity was later provided for this information to be shared at the group debrief.

#### Evaluation process

Evaluation forms for each day of the exercise were provided by MCDEM. The forms focused on the national objectives and KPI's and included sections on lifelines, welfare and business continuity. These were completed online and submitted via survey monkey.

Northland CDEM also submitted additional evaluation forms relevant to the regional objectives and KPI's as well as information regarding the preparedness work carried out before the exercise commenced.

### Recommendations

Overall the exercise was extremely valuable. It was a great opportunity to cement some of the existing inter-agency relationships already in place, as well as develop relationships with new agencies and organisations. There was a large amount of work required to carry out an exercise of this size and while staff were pushed to their limits at times, there were definite benefits to completing such a large volume of work.

The following are recommendations for the Northland CDEM group to consider when developing future work programmes:

## ISSUE: Emergency Management Information System (EMIS) Update

#### Introduction

This report is to provide an update on the Emergency Management Information System (EMIS) nationally and regionally in the last three months and an overview of the completed Northland EMIS Implementation Project over the last 18 months.

## National

The National EMIS User Group met on 27-28 October in Wellington to discuss the development of EMIS version 3.0 and answer some of the questions raised from feedback on the Official EMIS Requirements documents. The Central Agencies Shared Services Project Team held workshops over the two days. A representative from the Ministry of Health also joined the group to discuss system similarities moving forward of the two EMIS Sites (Health and CDEM) and how they can work together better.

A representative from the Northland CDEM Group was unable to attend the meeting but comprehensive feedback from Northland was included in the meeting on the following Version 3.0 topics:

- Layout of the new system
- Alerting tools and set up
- Detailed content on a number of EMIS core components, including resources

The decisions from the workshops can be given in a verbal update.

Lower level improvements and enhancements to the current system were also discussed and approved to maintain use for the next 12 months.

The National EMIS Governance Group met on 18 November. A verbal update can be given

## Regionally

The Northland EMIS Implementation Plan has been completed to date. Over the last 18 months the EMIS Implementation plan has been completed, including user training, exercises and management and upkeep of the sites. The completed project plan is attached.

## TITLE: Welfare Coordination Group Update

#### Introduction

This report provides an overview of Welfare Coordination Group (WCG) activities since the last WCG meeting held 4 November.

## Discussion

The Welfare Coordination Group meeting was held on the 4 November and was attended by a number of agencies. Updates were given by agencies during the general meeting and a workshop followed to build on Exercise Rauora which was a police led exercise held in October. Attendees used Kobo, an international internet based data collection tool, to register fictional people who had been part of the mass rescue from a sinking cruise ship. Participants were able to register affected people with limited training using mobile devices. The use of Kobo in Northland for the collection of data is being developed.

As part of the workshop, WCG members were given the opportunity to put forward ideas and priorities for the 2017 work program which is under development.

Claire Nyberg and Kim Abbott attended the Group Welfare Managers forum in Tauranga in October. This forum was held over two days to enable enough time for presentations, updates from each of the 16 regions and workshops on Exercise Tangaroa welfare corrective actions. The updates from all 16 regions illustrated that good progress is occurring to implement the changes introduced last December but that collectively we are facing many of the same challenges such as:

- Engagement from some of the sub-function responsible agencies and supporting agencies
- Waiting for national direction/plans to be completed or starting without them
- How to engage the nigh number of people now required to staff the welfare function
- Elevating welfare in local councils to ensure the right level and right amount of engagement.

Ben Ingram from Taranaki gave a presentation on the 2015 floods and posed a very good question in regards to "do we provide welfare to meet people's survival needs or to make them comfortable?". It's the digestive biscuit versus the chocolate Tim Tam conundrum. This topic possibly needs further discussion so that nationally we are providing the same level of welfare during an emergency across the country. Also discussed was the supply of cigarettes and alcohol as part of dropping in resources to isolated households. By denying people their usual supplies will we be adding to their stress levels and decreasing their psychosocial recovery? A debate ensued with varying opinions.

Ben's presentation was followed by a presentation by Jessica Peterson from the Canterbury CDEM Group which was a heartfelt and honest look at psychosocial recovery in Christchurch. The presentation focused on what support was available and that funding for this support was starting to be with-drawn when some of the worst psychosocial affects were just beginning to manifest themselves in some demographics. Jessica warned us that one more event could push many people over the edge. Little did she know the full meaning of her words with another earthquake and tsunami evacuation occurring less under a week after she spoke.

Wayne Ricketts the National Animal Welfare Coordinator for the Ministry Primary Industries (MPI) gave an update on the Animal Welfare Sub-function. MPI are still in the process of awarding the contract to the winning tender. They envision that there will be 4 animal welfare coordinators to cover the 16 regions.

Claire Nyberg gave an update on the Practical Tools for CDEM welfare Management resilience fund application which Northland CDEM are administering on behalf of the other 16 regions. Twelve improvement activities were developed based on a phone survey undertaken of 15 of the CDEM Groups. A working party with representatives from Auckland Council, Emergency Management BOP, Horizons/Manawatu, Christchurch City and Nelson/Tasman reviewed and prioritised these improvement activities when they met in October. Brendan Morris, the consultant engaged to carry out the work, is now developing one page project briefs and work will commence shortly on the highest priority activities

The rest of the forum was given to working in groups on the Exercise Tangaroa welfare corrective actions as identified by the Group Welfare Managers prior to the forum. The outcomes identified will be collated and assist with the National Welfare work programme which is being developed for 2017.

Graeme MacDonald attended the second workshop for the registration and needs assessment project. The process developed during the first workshop was refined by participants and it was agreed that civil defence will be responsible for carrying out rapid welfare needs assessments but that more detailed needs assessments would be carried out by the agencies responsible for their sub-functions using their own systems.

A Civil Defence Centre training workshop was held on the 26<sup>th</sup> November in Onerahi with a number of participants attending to learn how to work within a Civil Defence Centre. A verbal update can be given.

Kim Abbott was deployed to the Kaikoura Earthquake response as Group Welfare Manger in the Canterbury Emergency Coordination Centre. A verbal update can be given.

# TITLE: Community Resilience

#### Introduction

The purpose of this report is to provide an update on the various community resilience projects and tasks carried out by members of the Northland Civil Defence Group. This report includes updates on Vulnerable Groups, Electronic Community Response Plans and Marae Preparedness.

#### Community Response Plans Online (eCRP's)

New plans for Mahinepua-Wainui-TeNgaere, Hihi, Ahipara and Helena Bay are almost complete with meetings underway with the respective community response groups. The new tsunami inundation zones are still being finalised and when this is done, the new maps will be incorporated into the plans currently in the electronic format.

To date there are 32 eCRP's on the Northland Regional Council website. In the time from 1<sup>st</sup> February to 31<sup>st</sup> October, the community response plan page had received 832 page views and 580 eCRP's have been down loaded from the website.

# Youth in Emergency Services (YES) Programme

The YES programme is designed to strengthen and encourage the connection of local teens with their community by engaging them with emergency services. The programme allows for 15 young people aged 16-19 to participate in a hands on programme giving them an introduction to the emergence services, encouraging them to volunteer. The programme is funded by the Ministry of Youth Development and to date Northland has coordinated four programmes across the region.

This year, two programmes were run in Northland; one in Bream Bay in March and the other in Hokianga in May. Feedback from the young people, their families and from the coordination groups has been very positive with 35 participants graduating this year from the programme. The slightly different format (combining the agency orientation days to include two agencies in one day) this year was well received by all participating agencies and many personnel have offered to assist with the programme in other areas in the future.

Northland CDEM have applied for the \$10K funding available to coordinate a YES programme in Dargaville in 2017. If successful, liaison with the emergency services in the area will be underway shortly.

The outcome of this application is still pending.

#### Marae Preparedness

Currently five marae are working through the process of developing plans; Ngunguru, Akerama, Whakapara, Waiomio and Matihetihe. Akerama have agreed to be the lead in clustering four marae around the area to complete plans and are interested in first

#### Media and social media



# A GUIDE FOR GOVERNANCE

An existing handbook for elected members, which was at least 10 years old, has been rewritten and reprinted by the Group and is being progressively used in inductions for councillors across all four Northland councils. This document summarises the effective ways of working together that have been developed in Northland and has already been provided to NRC councillors as part of a presentation by the Northland CDEM team.

#### PUBLICITY FOR TSUNAMI SIREN TESTING

As part of a wider review of the tsunami activation and testing procedure, opportunities were identified to further streamline and consolidate publicity and advertising for the six-monthly tsunami siren tests.



# Northland CDEM photographic library

The Northland CDEM photographic library has been boosted over this reporting period with images added from a number of civil defence events.

These include on-the-day biannual tsunami siren testing, Exercise Tangaroa (three days and cold debrief), Exercise Rauora, CIMS4 training, Welfare Coordination Group (WCG) meetings, Mangawhai markets tsunami-readiness-themed visit and follow up public meeting and NZTA State Highway One roadside promotion of upcoming tsunami siren testing. Photographs and a video recording of the tsunami siren testing were produced.

The Exercise Tangaroa photos were put into a photo story about Northland's involvement in the national exercise. Participants from Northland Regional Council and the region's three district councils all feature in the slideshow.

This was shown for a month as a slideshow on the NRC's Whangārei reception wallflower (large screen). It was also shown at the Civil Defence induction for NRC

councillors, the November WCG meeting and to a Whangarei District Council staff meeting.

The photo story was also sent to MCDEM upon request, along with Northland's Exercise Tangaroa photos for various uses including the national exercise's final report.

Exercise Rauora photographs were requested by New Zealand Search and Rescue which helmed the event, along with Maritime New Zealand.

#### Public education

CDEM branded resources were developed to support a number of civil defence activities.

These included flyers, poster, bookmark and Northland-themed stickers to affix to new MCDEM booklets from the Never Happens? Happens booklet. The resources were used to support Kaipara District Council Community Response Group work, the Mangawhai markets tsunami-readiness-themed visit and follow up public meeting. The bookmark promoted <u>www.facebook.com/northlandcivildefence</u>.

Public education was also carried out with the Onerahi tsunami siren monitoring volunteers after this spring's testing.

#### Summer Safety Day

The Group was again a partner in organising – and represented with a stand – at the annual Summer Safety Day at Kensington Park in early November. This is a family-oriented event involving the major emergency services.

The organising team has been working together for two years and is looking at other possible opportunities.

Public education carried out elsewhere in the region is covered in other sections of the agenda.

#### Introduction

The purpose of this report is to provide an update on the Civil Defence Emergency Management Amendment Bill, which primarily focuses upon establishing Recovery Manager positions and powers.

#### Discussion

The Civil Defence Emergency Management Amendment Bill was passed on 10 November 2016. Attached for the Information of the group is a letter from The Director Civil Defence & Emergency Management, Sarah Stuart-Black.

For the information of the group this matter has been the subject of earlier reports and updates as the bill has progressed.

With the adoption of the new bill the changes signaled for recovery include that

- Group's shall have a Group Recovery Manager and may have local Recovery Managers.
- A Group Level Recovery plan consistent with the new legislative changes will be required

Until now the Group Recovery Manager appointment has been shared between the CDEM Manager and an appointed experienced Consultant. The amendments to the Act clearly signal the expectation that Recovery Managers positions at the Group level are similar to those of a Group Controller.

Initial scoping suggest that a .5 FTE will be required for the Northland CDEM Group Recovery Manager.

#### Passing of Civil Defence Emergency Management Amendment Bill

It is with great pleasure that I inform you that the Hon Gerry Brownlee, Acting Minister of Civil Defence, has announced the passing of the Civil Defence Emergency Management Amendment Bill with its focus on strengthening the legislative framework for recovery.

The Act recognises the importance of good recovery planning to help ensure that communities get back on their feet more quickly after an emergency. It also recognises that some powers are needed after the state of emergency phase. It removes the need to keep states of emergency in place and recognises that recovery is different and will involve different or additional stakeholders to those involved in response.

The key changes made by the Act include:

- establishing a legislative framework, including the statutory role of 'recovery managers'
- strengthening the requirements for recovery planning by requiring CDEM Groups plans to provide for strategic planning for recovery
- establishing a transition notice mechanism, with powers for a specified period of time (local or national transition period)
- making minor and technical changes to improve the Act, and consequential changes to other legislation and the National Civil Defence Emergency Management Plan Order 2015.

The majority of the Act comes into force on 180 days after Royal Assent.

MCDEM has produced a series of fact sheets to support people whose roles and responsibilities are affected by the Act. After Royal Assent these will be available on MCDEM's website.

#### Ambulance representatives

The Act provides that a senior ambulance service official may be co-opted onto a Civil Defence Emergency Management Coordinating Executive Group.

#### Next steps

The majority of the Act comes into force on 180 days after Royal Assent. This allows CDEM Groups time to prepare for the changes.

By 18 months after Royal Assent CDEM Groups must amend their CDEM Group plans to provide for the strategic planning for recovery from the hazards and risks in their area and the arrangements for giving transition notices. It is my expectation that Coordinating Executive Groups are involved in the recovery planning that CDEM Groups undertake.

#### Where can I find a copy of the Act?

Once the Bill receives Royal Assent (expected shortly) it available on the government legislation website <u>www.legislation.govt.nz</u>.

On a personal note, it was wonderful to hear widespread thanks and recognition for the great work that the civil defence emergency management sector does by Members of Parliament during their speeches in the House. The passing of the Act is a very positive step to further strengthen our framework to effectively assist and provide for recovery from future emergencies.

# TITLE: Far North District Council Update

# Background

This report provides an update on the Civil Defence and Emergency Management activities within the Far North District over the past 3 months.

# **Readiness Projects and Activities**

- Far North District Council staff participated in National Exercise Tangaroa. Day 1 of the Exercise was run in the council chambers in a workshop type format using the exercise as an opportunity to test local operating procedures, engage with local communities and strengthen relationships prior to and on the exercise dates. Council CDEM staff participated the Welfare and Recovery phases of the exercise (days 2 & 3) with other agency groups hosted by the Northland Regional Council and Whangarei District Council respectively.
- A full EOC set up was carried out in September to test equipment and upgrade or replace as required. Some minor technical IT issues were identified during Exercise Tangaroa which has now been addressed. Another set up is planned for later in the year.
- A public education program targeting schools to promote tsunami awareness in the form of a tsunami short movie competition sponsored by local businesses as part of exercise Tangaroa and to coincide with Get Ready Week has been completed. The program concluded with judging of the movies carried out by film director Florian Habicht and presentation of the prizes by CDEM Group Chair Colin (Toss) Kitchen to the winning schools.
- Civil Defence Officers have attended meetings over the past 3 months at Rawene, Waikere, Taipa, Russell, Punguru and Mitimiti as part of the CDEM work plan to review community response plans and support community resilience.
- Civil Defence Officers have been working with the Northland DHB Renal Unit to assist with promoting personal preparedness for patients who require dialysis. A workshop was attended in Kerikeri in September with patients and renal social workers as part of this initiative.

# Tsunami Alarms

- The Far North District Council has entered into an all of government contract with Meridian Energy as their network power supplier. As a result of this change the company proposes to charge the council 40 cents per alarm per day to cover administration costs of having the alarms connected to their network. This equates to \$8,468.00 per year which is currently unbudgeted. Discussions between the Far North District Council and Meridian to have this charge waived in the interest of public safety have not been successful and an agreement has not yet been reached. As a result of this impasse we have been unable to install additional alarms in communities identified as benefiting from this warning system.
- Testing of the tsunami alarm network was carried out across the region at the change of daylight saving 25th September. 6 alarms across the district were

reported as requiring maintenance which has been completed by Top Energy. Refer to agenda item for full report

## National Warning System

- Staff monitored a potential tsunami threat after an advisory message was issued at 0533 on Friday 9 September as a result of a magnitude 7.1 earthquake occurring off the East Cape of the North Island. This earthquake was felt and reported to Civil Defence by community response groups in Waikare and Russell. A tsunami warning was issued by MCDEM at 05:58. Subsequent updates were issued and a cancellation message received at 08:30.
- A test of the National Warning System was carried out by MCDEM at 1100am on 26 September. The notification was received and acknowledged as per standard operating procedures.
- Staff activated a partial EOC at 0141am on 14 November to respond to the 7.5 magnitude Kaikoura earthquake and subsequent tsunami threat. Following the activation of tsunami sirens staff relayed warning messages to community contacts throughout the morning. The tsunami threat to Northland was lifted just before 6.00am and the EOC was stood down at 7.30am. At the time of writing there have been no reports that sirens did not work and all community response groups were contacted at least three times during the response.

# TITLE: Whangārei District Update

#### Introduction

This report outlines the projects and activities of Civil Defence Emergency Management in the Whāngārei District during the last three-month period.

#### **Readiness Projects and Activities**

Community Response Group activities included the review of the Tutukaka, Helena / Teal Bay and Onerahi Community Response Group plans. The Waikaraka community coordinator carried out a leaflet drop at 400 homes in the area, advertising the local response group and the updating of the local telephone trees.

Bream Bay Emergency Services have joined together with the support of the CDEM Officer to formulate a Resources Plan for the Bream Bay area. Agency resources are moved during an evacuation, this plan sets out where resources are evacuated to and how a coordinated response can be undertaken to support the Bream Bay area for up to 72 hours with no outside assistance.

Agencies involved are, NZ Fire Service, NZ Police, Refining NZ, St John, Surf Lifesaving, Coastguard, CDEM and the Ruakaka Community Response Group, with input from Bream Bay College, LVL and Northport.

#### National Exercise Tangaroa

Day 2 and 3 of Exercise Tangaroa were completed. Day 2 was focused around Welfare. The Emergency Operations Centre was partially activated, the team developed an Action Plan, Sitrep, Media Release and Welfare arrangements. The local welfare managers took part in the CDEM Group Welfare Workshop.

Day 3 focused on Recovery, the transition from the duty Controller to the appointed Recovery Manager, the structure and set up of the Recovery Office and short, medium and long term recovery planning. The day was attended by representatives from across partner agencies and councils in Northland.

Evaluations were completed on the outcomes of the three exercise days and fed back into the Northland Exercise Tangaroa Debrief session.

The Exercise Tangaroa video produced by Auckland and Nelson Tasman CDEM Groups and the Northland CDEM Slideshow were presented at the All Staff Meeting. A number of new staff came forward to volunteer to be part of the CDEM team and will begin training next year.

The Northland Tsunami Activation and Testing Standard Operating Procedure Plan is under review. Northpower and Top Energy have aligned their activation processes and the siren testing media campaign has been brought under the Group Public Information Manager role. The Northland Tsunami siren network was tested on 25 September, the start of Daylight Saving. Northpower and Top Energy activated the sirens under the direction of the district Civil Defence Officers. Seven faults were reported from the 157 sirens across the region. Faults are to be expected with the harsh environment the sirens are placed in. All faults have been repaired.

The Emergency Operations Centre (EOC) has updated its Information Technology hardware and software. New laptops and new software have been installed across council, including a new document management system. This has been tested within the EOC environment to ensure continuity of response arrangements.

The CDEM Officer visited Kamo High School with the NRC Natural Hazards Advisor, to talk to year 9 students about climate change and how we are prepared for emergencies such as flooding and sea level rise.

#### Staff Training

The local controllers met to discuss and run through a desktop exercise relating to a cruise ship incident and Civil Defence as a support agency and the required welfare provision.

Building Inspectors from across the region attended a training session on 29 September to be updated on the Rapid Impact Assessment Building forms to be used during a Declaration. MBIE have developed forms, which have been transferred in the KOBO software in Northland to be used in the future.

Exercise Arab Crude Part 2 was held on 25 November, attended by CDEM staff and Refining NZ staff. A verbal update can be delivered.

Volunteers, Welfare Managers and Northland Welfare Coordinating Group representatives attended a one-day course, on the Integrated Training Framework (ITF) Intermediate Civil Defence Centre Course in Onerahi on 26 November at St Stephens Church.

#### Meetings and Professional Development

The Local Welfare Managers and Welfare Support Team have started monthly meetings to work through the MCDEM Guidelines to Welfare Services in an Emergency and to review the local welfare arrangements and to align the local welfare plan with the latest Group Welfare plan.

The Public Information Managers (PIM) met to discuss their learning from Exercise Tangaroa and what a PIM mentor programme could look like.

# TITLE: KDC update

## Introduction

This report provides an update of the civil defence and emergency management activities within the Kaipara District over the past 3 months. Attached is a work plan which was developed for the Kaipara District Council executive team.

#### Key points include

- Tsunami warning on 14 November 2016 following Kaikoura earthquake. CDEM officer and controller responded and monitored situation from their homes. Tsunami Sirens activated at 0148 hours by CDEM group controller. Kaipara EOC staff were not required, as situation downgraded. More education with coastal communities is required in the future. A number of people are still confused as to what to do when hearing the tsunami siren and a number reported being unable to hear sirens. We continue to work with our coastal communities to raise awareness of tsunami risk and the need for personal responsibility and planning. See further information on Northland CDEM report re this event.
- 2<sup>nd</sup> September 2016 Tsunami warning following East Cape earthquake. The Kaipara CDEM officer and controller responded to alerts and monitored situation in conjunction with personnel from the CDEM group. The Mangawhai Beach School closed as a precaution. A number of Mangawhai locals raised questions about tsunami potential, preparedness and the siren system. This was followed up with a public meeting held in on the 24th of September at Mangawhai. Several staff also attended the local markets giving out advice and information. New members have been recruited for the Mangawhai community response group. This group has met twice and is updating the local response plan and will be engaging with the community in the future.
- Kaipara District Council participated well in exercise Tangaroa with its largest number of staff participating in the national exercise. New learnings were shared including rapid assessment and use of KOBO. Future training for staff has been identified including ongoing induction of new staff, CIMS4 and EOC function training. A training calendar for 2017 is being finalised.
- Community engagement has increased in some areas due to the recent earthquakes.
