Waka Kotahi would like to acknowledge NTA in completing a record delivery of work despite the setbacks including wet weather exacerbating roading, causing little rehabilitation works.

WDC are currently undergoing two independent reviews where the scope has been agreed by the CE's of each council:

- 1. Looking at maintenance contracts, review existing contracts and provide recommendations for future contracts.
- 2. Review on the performance of NTA and if it is meeting Northlands requirements. Both reviews are independent reviews and findings will be shared with each district councils CE.
