

The purpose of this report is for the Board to endorse the speed limit signage concept produced by Richard Murray as commissioned by the iwi representative board members.

This is an alternative design to that proposed by Northland Transport Alliance (NTA) to ensure that the signage reflects the aspirations of the Board to educate communities that access the beach versus an enforcement statutory approach.

At a workshop held on 28 August 2023 board members received an update from Graeme Neho on behalf of Richard Murray.

It is recommended that the Board endorse the following:

- The speed limit signage design be formally approved by the Board.

- 2. That the speed limit signage design be formally approved by the Board.
- 3. That a fully scoped proposal be put to the Board at their next meeting for formal approval and, if approved, that quotes are to be obtained for the erection of signage.
- 4. That the Technical Steering Group work with NTA in relation to the wider speed limit review and the proposed signage.

Background/Tuhinga

At the Board meeting held on 28 April 2023, Northland Transportation Alliance (NTA) presented new speed limit signage designed to meet the legal requirements of the Setting of Speed Limits Rule 2022 and previous direction received from the Board for feedback and endorsement from the Board.

- Key considerations in the design included:
- Meeting legal requirements under the Setting of Speed Limits Rule 2022
- Consistency with the Te Oneroa-a-Tohe Management Plan
- Ensuring that signage in bi-lingual

Ensuring the signage is understandable to all beach users, including overseas tourists who may not have English as a first language.

The Board noted that the signs needed to be visually engaging to the local people and include the Te Oneroa-a-Tōhe logo as this could lead to a more respectful response. Graeme Neho contacted the original logo designer, Richard Murray, and an alternative design was emailed out to the Board and presented at the May workshop. A further meeting was held with Shawn Baker (NTA) on 28 June 2023 where a number of issued were raised by the Board.
