Kerikeri-Waipapa flood scheme

Kerikeri-Waipapa flood scheme Council has decided to fund the ongoing flood works in Kerikeri-Waipapa, from the existing Kerikeri-Waipapa flood scheme reserve. The rivermangement rate for this area was stopped after after the works were put on hold. The proposed work includes stopbanks atWaitōtara Drive at a cost of \$140,000, and work to protect the Waipapa Industrial Estate, at a cost of \$200,000. This work is planned for 2018 - 2021. We will consult with the community again if any major additional works are proposed. This work does not require any contribution from the proposed region wide flood infrastructure rate, or any targeted flood rate, as the existing reserve balance is sufficient
