Mr Gosling advised that he is a tree surgeon with 25 years' experience nationally and overseas. He wanted to raise his concern about the lack of protection for trees in Northland, in contrast to other areas for example, Auckland City. He has talked to the district councils and wanted to make the Northland Regional Council aware of the situation.

Chairman, Cr Blaikie advised that under the Resource Management Act, the Northland Regional Council looks after soils but not trees. Protection of trees comes under the district councils within their district plans.

Cr Yeoman advised Mr Gosling that the Far North District Council will be consulting on their district plan and that making a submission to the district plan will be the best way to influence the council and its rules.
