Rivers team are currently implementing the recommendations of the five yearly CDSR review.

Discussion around the silt left after rain events and the impact this can have on the streams. The planting that has taken place is assisting with the silt however this is not enough. The Working group agreed for more planting to take place and to use contractors rather than having to rely on volunteer help.

Because the Hopua te Nihotetea Detention Dam is designed to hold water for 2 days, holding water for longer periods for silt deposition would compromise the dam's ability to detain flood water with back-to-back flood events.

Planting the previously grazed paddocks may help reduce run-off from the NRC dam land. The Rivers team to connect with the local planting specialists Te Parawhau SilverCom for recommendations on planting at the dam.

## Raumanga Stream - Remedial works (Item 3.6)

Community voicing concerns around weed/logs in and around stream and the potential for the stream to flood. Because of the Hopua te Nihotetea Detention Dam, the Raumanga Stream is a reduced flood risk and the weeds along the bank present as an eye sore rather than a flood risk.

There are a number of Flame trees in and around the banks however, the Whangārei District Council are currently executing a project targeting pest weeds.

NRC inspect the Kirikri Street Stream annually and remove any trees blocking the stream.
