It is important that we undertake this critical work to ensure we don't have lengthy closures like we have experienced on SH1 through the Mangamuka Gorge.

NZTA have committed \$61m for the Brynderwyn Hills resilience work. There will be additional costs incurred due to operational activities to meet resource consent requirements, additional material being removed and re-opening of the corridor over the Easter break.
