#### Secretarial Note:

- A verbal update was provided on the performance of council's managed funds during the month of April. These funds had incurred losses of \$233,000 which resulted in the total fund gains from managed funds being \$4.584m and the total variance being \$1.696m.
- The latest projected financial position for the end of the financial year was approximately an \$800k year-end surplus (not including gains).
- Concern was raised that council was required to confirm its rates increase through the Long Term Plan process prior to understanding the year end position. In response it was reminded that surpluses were 'one off' and could not fund ongoing programmes.
