Matters raised:

- Noted Deer update. Completed second round of activity via helicopter. Ground hunting
 with dogs to target specific locations of deer. Really good support from community. Next
 project area Kai Iwi lakes and yet to progress planning stage. Deer jaw bone samples and
 scat surveys are mapping movement of deer. The final round of helicopter surveillance
 spotted six deer, four of which were captured.
- Noted Ngāti Pāoa lead by John Hutton engaged for business case for research, control and elimination of Caulerpa. Letter sent to Minister Hoggard for support of business case. Staff supportive to engage with MartinJenkins.

RPMS review (Item 4.3)

Matters raised:

- Noted RPMS is RPMP.
- Noted to consider new approaches.
- Noted grateful for the in-house work that is being undertaken.
- Noted what is tika and pono, and what are the prescribed methods
- Noted work is being undertaken in-house with managers for completion by end of August.
- Noted viewing the change to consultation process outreach with tangata whenua to be engaged/consulted prior to writing a paper in March for July.
- Discussion on strategy has to be in RPMP to have the room to cover out-of-box changes to strategy.

Marine Protected Areas (Item 4.5)

- Noted council support for RMA/Fisheries Act reform of maintaining status quo.
- Noted ecological monitoring being undertaken. Surveying being undertaken inside and outside of Rāhui Tapu area.
- Noted the need to continue with surveying of areas.

Taharoa Domain (Item 4.6)

Presented by: Nicky Fitzgibbon, Biosecurity Manager - Incursions and Response

Matters raised:

• Discussed plan available from Taharoa working group in collaboration with local hapū, KDC and DOC actions to date able to be shared with members.

- Discussion on water quality is primarily within band A-B range water quality is good. There is a loss of vegetation.
- Noted NRC letter in response to KDC advert. KDC replied and will maintain responsibility. NRC to continue monitoring.
- Discussed risk management perspective banning of boats, power boats on tohunga of lake, and sensitive nature of the lake.
- Discussed challenge of maintaining risk management on biosecurity through current position of responsibility.
- Discussed the three parties involved with gold clam and the financial costs are supported by NRC. KDC have ability to reduce further risk to limit access and activities on lake.
- Discussion on spread of Waikato gold clam is not yet in the lake. Council has the responsibility for monitoring and reporting to MPI should there be any identification.

Kauri Protection (Item 4.7)

Currently no funding secured for the Far North. Need to use window of opportunity to act early. Discussed risk assessment as long-term threat of further invasion. Discussed DNA samples being sent to MPI to source where the sea spurge is coming from.
