Distributed copies of the Northland walking and cycling strategy document, explaining its creation and involvement of various councils and organizations. Highlighted the economic benefits of the project, including the creation of 265 jobs and an annual contribution of \$165 million to the GDP. Mentioned the \$33 million application to the Regional Infrastructure Fund and the comprehensive business case supporting it. She recommended that the project be reported through the Regional Transport Committee to ensure regular updates and support from key organizations.

Secretarial notes:

- Rail volume from Fonterra is now 16 wagons per day from its factory to Kauri
- Each tonne of freight moved by rail results in a 70% reduction in carbon emissions compared to road transport
- The repair work on the North Auckland Line (NAL) continues to bed down well with repeated rail movements. Ballast tamping and rail destress work is programmed for this month. Bridge maintenance programme progressing on target
- Repair work to secure bank at site 228 substantially complete
- Otiria Continuing to develop relationships with Bay of Islands Vintage Railway Trust through MOU, lease and material
- Marsden Point Rail Link Final lad purchase settles on 28/2/25. Second stage of Geotech investigations underway. Site walkover with Patuharakeke and Parawhau on 29/1/25. Design options meeting (particularly along the causeway) held with NZTA on 28/1/25. Continuing with consent/designation discussions with NRC and WDC

Secretarial notes: Highlighted the decrease in deaths and serious injuries since 2024, attributing it to increased enforcement and collaboration among agencies. Emphasized the role of increased police enforcement on alcohol and speed, as well as the alignment of messaging among road safety partners. There has been an increase in drug impairment with nearly a third of fatalities involving drug impairment.

The need for a regional integrated transport strategy was emphasized, with discussions on updating existing strategies and incorporating resilience and security considerations.
