National Bus Driver Shortage

Ongoing conversations with other regional councils have shown that the bus driver shortage nationally is progressively getting worse with some councils being unable to cover all timetabled services. It is anticipated that this situation will continue to worsen over the coming months.

The adverse impact on the contracted Link services in Northland is beginning to be felt. Staff remain in talks with operators on how best to manage the situation.

The planned Whangarei urban scholar services have had to be put on hold as the operator is struggling to source drivers to cover these services. Staff will be meeting with the operator during April to address this issue going forward.

Half Price Fares

There has been no noticeable increase in the number of people using the Link services since the introduction of the Half Fare initiative. One mitigating factor may be that nearly half the number of SuperGold card holders carried prior to the onset of Covid have not returned to the CityLink service.

In addition, it must be noted that the number of passengers carried in April 2022 are lower due to school holidays and the number of public holidays observed.

Kamo T2 Lane

The Whangarei District Council has allocated funding for the Kamo bus lane as part of the 2021-24 LTP and the Northland Regional Council has made provision in their LTP for increased bus services associated with the bus lane.

The Whangarei District Council has completed a Point of Entry application for the project with NZTA which allows the funding for a Single Stage Business Case to be released. Council has engaged Flow Consultants to complete the Business case which is required by NZTA to release the construction funding.

The proposed timing of the project is for construction to be undertaken during the 2022/23 financial year with operation of the bus lane by 2023/24 or sooner if possible.

Rose Street Bus Terminus Upgrade

The Rose Street upgrade is running two weeks behind schedule.

Staff have received 2 quotes at this stage for upgrade of the Rose Street Terminus office accommodation.

The use of temporary stops in Vine Street has been successful to date. Since the commencement of the new school term however, incidents of antisocial behaviour have restarted.

Antisocial Behavior at Vine Street Bus Stops

There is an increasing number of bicycles being ridden in Vine Street and on the pavements in and around the temporary bus stops.

This was reported to both the New Zealand Police and the Whangarei District Council for their attention and actioning.

Good morning All. Chris this issue has also been raised by Dave Palmer from WDC. With the temporary movement of the bus bays to Vine street this has contributed to the issues of these riders taking part in risky behaviour as shown in the videos. It has also contributed to the increased amount of the public on this short length of roadway.

A conversation with our Road Policing Manager Senior Sergeant Terry Phillips has already occurred about the issue. Terry will be able to assist and provide some staffing to address the issue.

We will use a mixture of road enforcement laws and local By-laws in concert with visible policing to try and address the issue.

Public Places Bylaw 2014

September 2014

- 33 Control of Skateboards, Roller Skates and Bikes
- 33.1 No person shall use any roller skate, scooter or skateboard in any public place within the areas detailed in Appendix III provided always that the use of any wheelchair, pushchair, perambulator, trolley, cart or other transportation of disabled persons, young children, elderly persons or their personal effects shall not be a breach of this clause.
- 33.2 No person shall ride a bike on the footpath or in any mall within the areas detailed in Appendix III.
- 33.3 No person shall use any bike, roller-skate, scooter, mobility device or skateboard in any public place so as to cause damage to any property or person or in a manner which is without reasonable consideration for other persons using any public place.

35 Seizure

Seizure of property not on private land

Council has powers of seizure of property not on private land under the Local Government Act 2002.

An enforcement officer may seize and impound property in a public place if:

- a. The property is materially involved in a breach of this bylaw, and
- b. It is reasonable in the circumstances to seize and impound the property, and
- c. Before seizing and impounding the enforcement officer
 - i. directed the person committing the offence to stop committing the offence
 - ii. has advised the person committing the offence that, if he or she does not stop committing the offence, the enforcement officer has the power to seize and impound the property, and
 - iii. provided the person with a reasonable opportunity to stop committing the offence.
- d. However, if the property is not in the possession of a person at the time the enforcement officer proposes to seize and impound the property, the enforcement officer does not have to comply with clause 35c.

164Seizure of property not on private land

(1)

An enforcement officer may seize and impound property that is not on private land if—

(a)

the property is materially involved in the commission of an offence; and

(b)

it is reasonable in the circumstances to seize and impound the property; and

(c)

before seizing and impounding the property, the enforcement officer—

(i)

directed (orally or in writing) the person committing the offence to stop committing the offence; and

(ii)

has advised (orally or in writing) the person committing the offence that, if he or she does not stop committing the offence, the enforcement officer has power to seize and impound the property; and

(iii)

provided the person with a reasonable opportunity to stop committing the offence.

However, if the property is not in the possession of a person at the time the enforcement officer proposes to seize and impound the property, the enforcement officer does not have to comply with subsection (1)(c).

(3)

As soon as practicable after seizing and impounding property, an enforcement officer must give a notice in the prescribed form—

(a)

to the person in possession of the property at the time it was seized and impounded; or

(b)

if paragraph (a) does not apply, to any person who the enforcement officer can ascertain is the owner of, or has an interest in, the property.

(4)

In this section and section 165, offence—

(a)

means an offence against this Act; and

(b)

includes a breach of a bylaw.

Hi Sandra,

This type of incident has caused the Community Safety Officer a great deal of frustration over the last 12 months where it has become an increasing problem. There have been 5 occasions in the last couple of weeks alone where CitySafe have attempted to intervene to stop a bike or felt the need to call for police support, but the Police, whilst indicating their arrival, never made it. This largely down to a higher priority call, but it leaves CitySafe in a difficult position.

This week the Community Safety Officer has again been in touch with Police DCC to address the problem. The Police have asked for some clarity about what CitySafe can and cannot do a dialogue on this finally getting some headway.

The situation has been compounded by the reality that CitySafe have tried to strike a balance on seizures while the Beam eScooter trial has been going on as this has created something of an unhelpful grey area, particularly around the CBD/Mall area/. They could take a much tougher seize stance, but this would not be backed up by legislation and come down to Council's appetite to be more assertive and its preparedness for the response. If we had more community policing present in and around the CBD it would likely become less of an issue, but that is still some way off.

As it happens one of the more notorious Boys High bike bike boys nearly took me out in my car this morning off the shared pathway.

It is a problem; we are connected with Police on it, but it's not going away unless someone gets more assertive in response.
